CVM RESOLUTION Nº 7 OF SEPTEMBER 30th, 2020

Repeals normative acts and other non-normative acts as part of the process of revision and consolidation of normative acts as provided for in Decree nº 10,139 of November 28th, 2019.

The **PRESIDENT OF THE SECURITIES AND EXCHANGE COMMISSION (CVM in Portuguese)** makes public that the Collegiate **APPROVED** the following Resolution at a meeting held on September 29th, 2020, based on the provisions of Law nº 6,385 of December 7th, 1976, and Decree nº 10,139 of November 28th, 2019:
