#### **Conceptual Note**

Following the meeting of South American Presidents held in Brasília on May 30, 2023, where the commitment of the region's countries to work on improving the infrastructure and logistics of South America was reaffirmed, the event "A New Infrastructure Agenda for South America" will be held on November 6 and 7 in Brasília, at the Rio Branco Institute. The event will facilitate an exchange of ideas among government representatives from the 12 countries, experts, and representatives of international organizations working on infrastructure and transportation issues in the region.

This initiative, organized in collaboration with the Brazilian Cooperation Agency (ABC), the Alexandre de Gusmão Foundation (FUNAG), and the Institute of Applied Economic Research (IPEA), aims to foster a comprehensive reflection on the key elements that should guide the resumption of regional dialogue and cooperation in the field of infrastructure, considering its centrality for strengthening regional integration.

Taking into account the experience of the Initiative for the Integration of South American Regional Infrastructure (IIRSA) and the South American Council of Infrastructure and Planning (COSIPLAN), which have represented a historical milestone in efforts to enhance the physical integration of the region, the seminar will discuss priorities and challenges for the construction of a new infrastructure agenda. In addition to providing an updated overview of infrastructure in South America, the meeting will focus on identifying concrete actions that can reinforce the positive impact of a future agenda for physical and digital integration, taking into account the demands of all countries in the region to improve the living conditions of our populations and contribute to the common goal of promoting economic development.

With this objective, the seminar will discuss topics such as criteria for identifying priority infrastructure projects for South America, challenges in financing and capacity building for project development, regulatory challenges, and support for projects with positive social and environmental impacts.

In order to facilitate a broad exchange on the main aspects of the regional infrastructure agenda, discussions will be organized into four panels with presentations by experts, followed by debates among delegates from the signatory countries of the Brasília Consensus. On the second day of the event, a session will be held for authorities to promote discussion on possible lines of action and follow-up.
