CALL FOR PARTICIPANTS LAB ENC 2019

1. OBJECT

The National Circus School (ENC) Lab Program consists of a set of continued actions which aims to systematize the main actions already carried out by the ENC over its story and also consolidate the school as a space for reflection, research and experimentation in the circus arts.

1.1. Is object of this Public Call for the selection of projects with a view to interacting with the National Circus school in the period from 10 June to 20 December 2019, according to the following modules:

- A) MODULE A: Individual Residencies;
- B) MODULE B: Group Residencies;
- C) MODULE C: International Exchange.

1.2. Module C: International Exchange is characterized by offering circus foreign students a space for reflection, research and experimentation. The module aims to promote the creative process; providing the artist space-time required for the development of his/her language. The load time is set according to the needs of the artist and project objectives, depending on the approval of the ENC Coordination.

1.3. The selected projects shall be carried out between June and December 2019, according to the planning of Annex I.

2. ELIGIBILITY

2.1. Can participate in this Public Call:

- d) Circus Professionals or students from abroad.

3. REGISTRATION

4.1. Non-Brazilian:

- a) Copy of valid document: identity (Mercosul) or Passport;
- b) Proof of link with circus institution.

5. OBLIGATIONS

5.1 The selected candidates must comply with all the rules and regulations of the ENC, and participate in all events of the school whenever required.

5.2. The National Circus School will make available:

- a) Space for training, lunch, guidance on security in the circus, physical therapist, body preparation, guidance of teachers and pedagogical supervisor.
