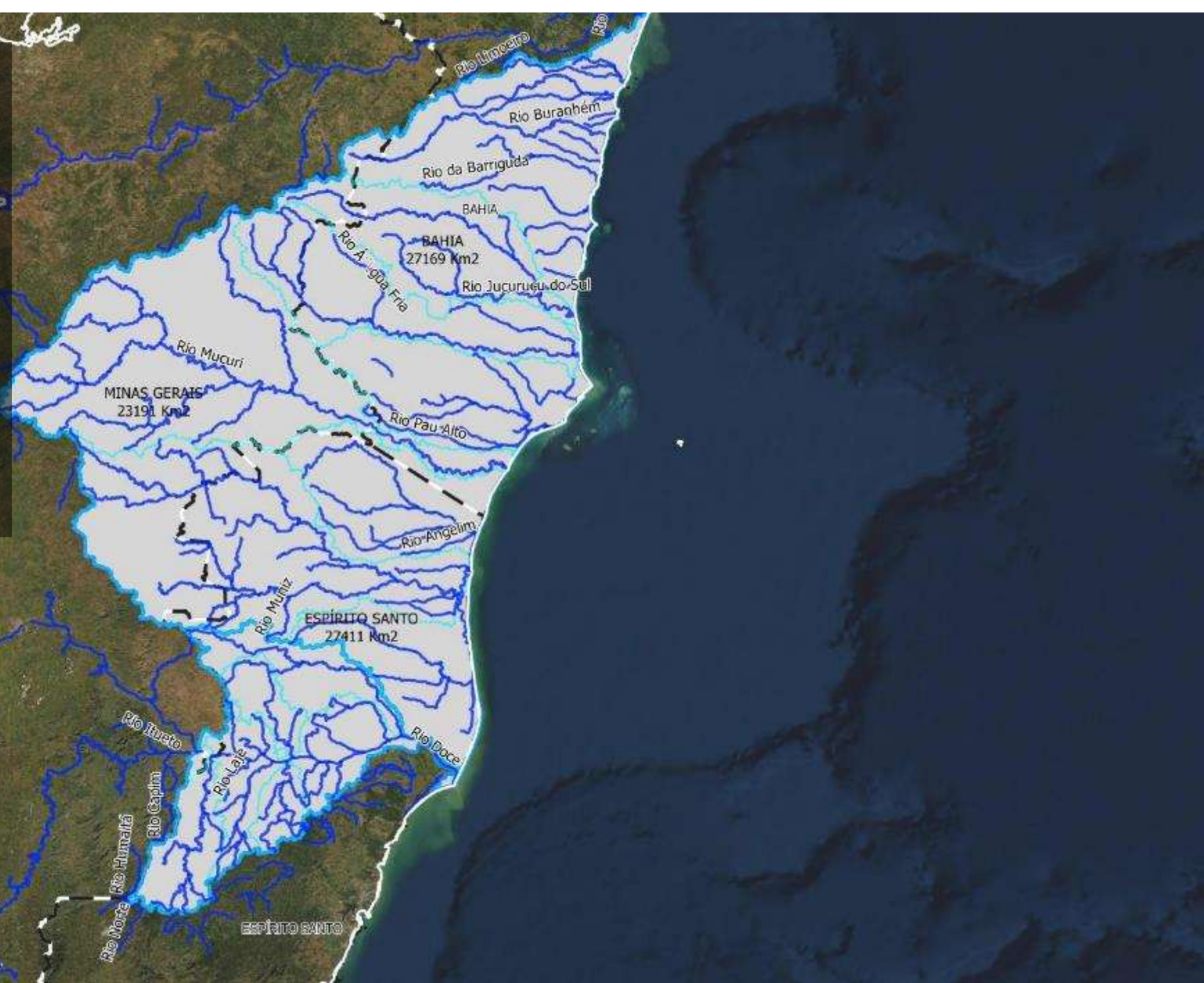
Rios e trechos de drenagem

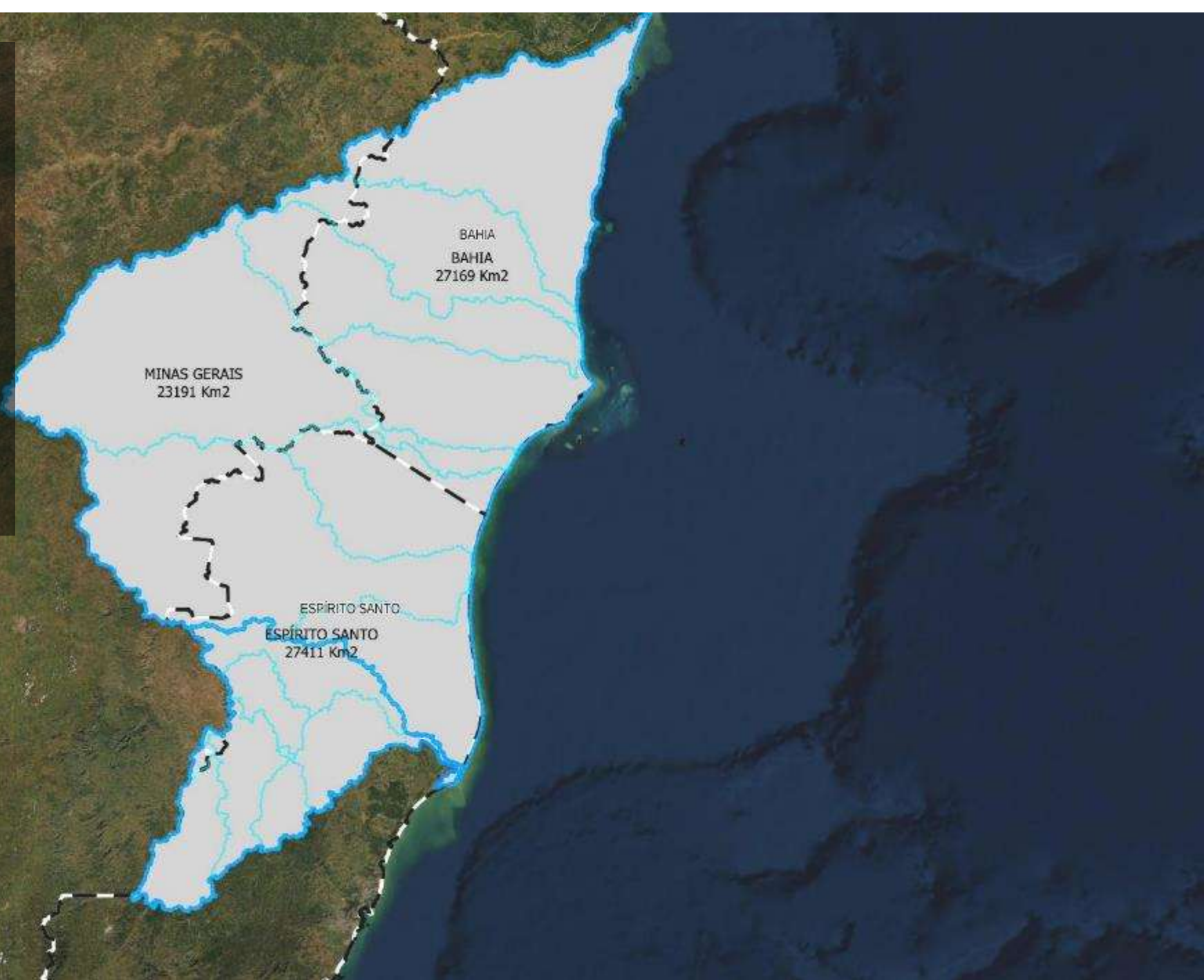
Rios com área opcional de MG
