About the OECD Responsible Business Conduct Policy Reviews

The OECD Responsible Business Conduct Policy Reviews examine the legislations, regulations and policies of a the country in selected areas covered by the <u>OECD Guidelines for Multinational Enterprises</u>, including human rights, labour rights, the environment, and anti-corruption. It also analyses other policy areas through which the government can exemplify RBC, either in its role as economic actor as procurer of goods, services and works or owner of companies, and shape business conduct through economic policies, such as trade and investment. On this basis, this Review formulates concrete and actionable policy recommendations aimed at providing support to the government not only to regulate and enforce in support of RBC, but also to leverage and incentivise responsible business practices. This Review constitutes therefore a key input to support the development of the National Action Plan on Responsible Business conduct and the National Action Plan on Business and Human Rights of Brazil.

About the Responsible Business Conduct in Latin America and the Caribbean project

This Review is developed in the context of the *Responsible Business Conduct in Latin America and the Caribbean* project (RBCLAC), implemented by the OECD in partnership with the International Labour Organization (ILO) and the Office of the United Nations High Commissioner for Human Rights (UN OHCHR) and funded by the European Union. The project seeks to promote smart, sustainable and inclusive growth in the region by supporting responsible business practices in line with the international RBC instruments of the three implementing organisations. The activities of the OECD taking place within the project are structured around three mutually reinforcing pillars: (i) reinforcing government policies for RBC, (ii) helping businesses to conduct due diligence in priority sectors, and (iii) facilitating access to remedy through the strengthening of the network of National Contact Points for RBC.
