The Brazilian NCP is an Interministerial Working Group and, until the end of 2022, was linked to the Ministry of Economy. At the end of 2022, there was a presidential election in Brazil which have repercussions on changes in the structure of the Ministries that compose the NCP, including the fact that, nowadays, the NCP is linked to the Ministry of Development, Industry, Commerce and Services.

It is composed of representatives of the following bodies and entities: I - two from the Ministry of Development, Industry, Commerce and Services (one from the Executive Secretariat of the Chamber of Foreign Commerce, who coordinate it, and other from the Secretariat for Green Economy, Decarbonization and Bioindustry); II - one from the Federal Attorney General's Office; III - one from the Central Bank of Brazil; III - one from the Civil House of the Presidency of the Republic IV - one from the Comptroller General of the Union; V - one from the Ministry of Agriculture and Livestock; VI - one from the Ministry of Justice and Public Security; VII - one from the Ministry of Environment and Climate Change; VIII - one from the Ministry of Mines and Energy; IX - one from the Ministry of Human Rights; X - one from the Ministry of Foreign Affairs XI - one from the Ministry of Labor and Employment.
